### 1. Call to Order and Quorum Establishment

- The meeting was called to order by David.
- A quorum was established with all board members present.

### 2. Previous Meeting Minutes

- **Motion:** To waive the reading of the previous meeting minutes (Frantz/Teta).
- **Result:** Approved unanimously.

#### 3. Roof Replacement Project

- Discussion:
  - Tampa Bay Roofing selected for the flat roof using a three-layer modified bitumen system (25-year warranty).
  - Munion Roofing chosen for the mansard replacement.
- **Motion:** To approve Tampa Bay Roofing for the flat roof and Munion Roofing for the mansard, totaling \$113,000 (Frantz/Teta).
- **Result:** Approved unanimously.

### 4. Parking Lot Resurfacing

- Discussion:
  - All Phase bid selected for resurfacing (\$17,000), including an additional \$3,000 for a thicker asphalt layer.
  - Expansion of parking spaces was deemed unfeasible due to cost and regulatory barriers.
- Motion: To approve the All Phase bid for parking lot resurfacing (Frantz/Teta).
- **Result:** Approved unanimously.

## 5. Landscaping and Irrigation Repairs

- Discussion:
  - o Ishmael Landscaping proposed \$3,200 to replace damaged plantings.

- o Irrigation system repairs required to ensure proper watering before replanting.
- **Motion 1:** To approve Ishmael Landscaping's \$3,200 bid for plant replacement (Frantz/Teta).
- **Result:** Approved unanimously.
- Motion 2: To proceed with irrigation system repairs (Frantz/Teta).
- **Result:** Approved unanimously.

### 6. Fence Replacement

- Discussion:
  - Reviewed Freedom Fence's bid for PVC installation (~\$7,150 for boundary fence).
  - Decision made to delay fence work until roofing is complete.

#### 7. Financial Updates

- Discussion:
  - Financial reports for September and October are missing due to transition issues.
  - o Managers to work with available records and finalize reports for board review.

### 8. Other Motions Made and Approved

- Motion 1: Purchase a new laundry cart for \$100 (Frantz/Teta).
